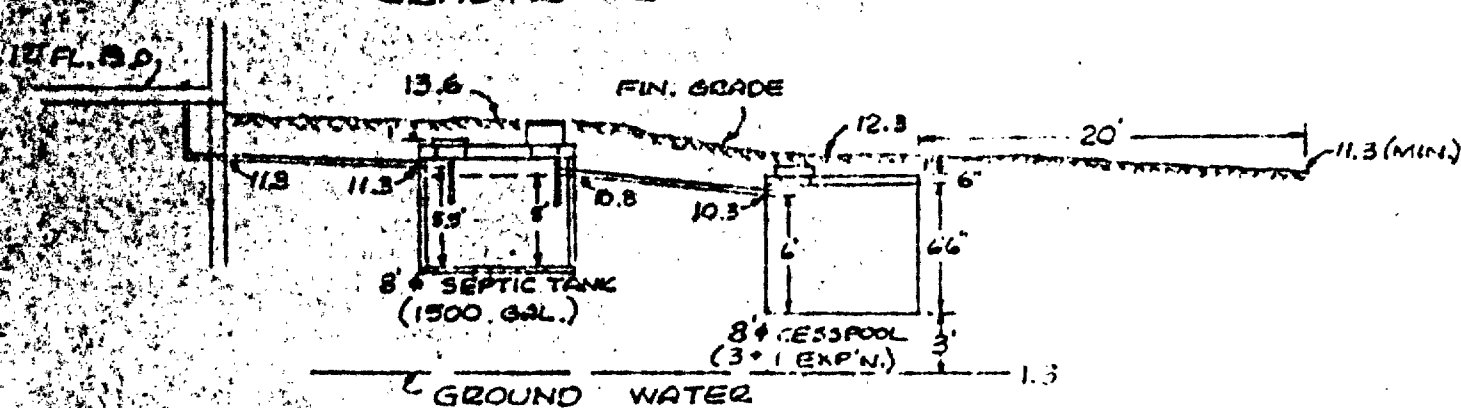

GRADING PLAN

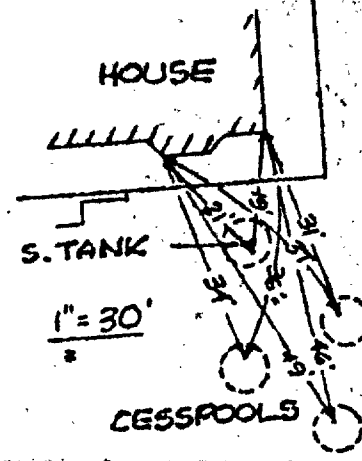


MAP OF PROPERTY SURVEYED FOR

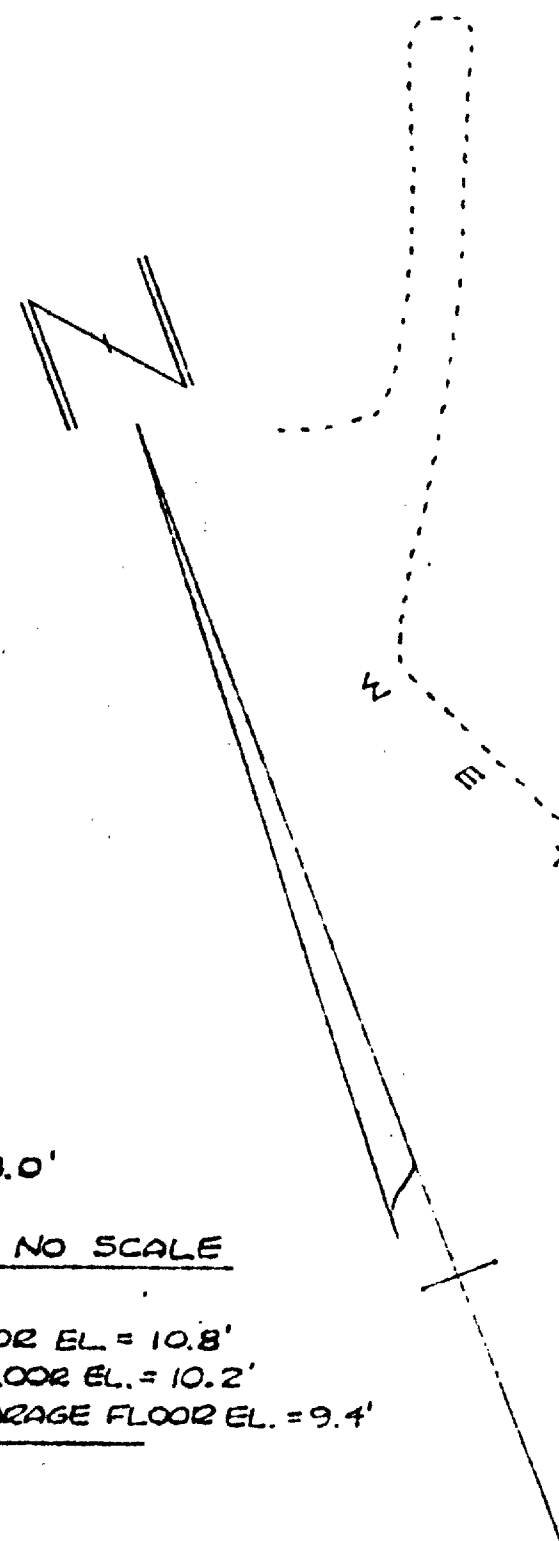
